



INVITATION TO BID FOR Construction of Four Storey Academic Building (CICT Building) Phase 1

The **CAMARINES SUR POLYTECHNIC COLLEGES**, through the **General Appropriation Funds (GAA)** intends to apply the sum of **Sixty Million Three Hundred Thirty Six Thousand One Hundred Twenty Eight Pesos & 43/100 (₱60,336,128.43)** being the Approved Budget for the Contracts (ABC) to payments under the contract for the **Construction of Four Storey Academic Building (CICT Building) Phase 1**. Bids received in excess of the ABC shall be automatically rejected a bid opening.

The **CAMARINES SUR POLYTECHNIC COLLEGES** now invites bids for the project **Construction of Four Storey Academic Building (CICT Building) Phase 1** shall include all management, labor, engineering materials, tools, equipment and services required to manufacture, assemble, deliver and install all items necessary for the proper execution and completion of the said items of works. This also includes all equipment and the performance of all operations necessary to perform Siteworks, Masonry Works, Fire Escapes and Acces to Roof, metal Roofing Works, Ceiling Works, Plumbing, Sanitary, Water System and Drainage System, Electrical Works and Ancillary Works of the project as indicated on drawings and specifications. All related works needed to have this work completed shall also form part of this section. Completion of the Works is required within _____ (____) Calendar Days.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, cooperative and partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.
