INVITATION TO BID FOR Improvement of Water Supply System

The **CAMARINES SUR POLYTECHNIC COLLEGES**, through the **General Appropriation Act (GAA)** intends to apply the sum of **One Million Six Hundred Seventy Nine Thousand One Hundred Ninety Seven Pesos & 44/100 (₱1,679,197.44)** only being the Approved Budget for the Contracts (ABC) to payments under the contract for **Improvement of Water Supply System**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The **CAMARINES SUR POLYTECHNIC COLLEGES** now invites bids for **Improvement of Water Supply System** shall include all management, labor, engineering materials, tools, equipment and services required to manufacture, assemble, deliver and install all items necessary for the proper execution and completion of the said items of works. This also includes all equipment and the performance of all operations necessary to perform **Pipe Drilling Works, Concrete, Masonry and Plastering Works, Plumbing Works, Drainage Works, Tiling Works and Water Quality Test and Other Ancillary Works of the project as indicated on drawings and specifications** of the project as indicated on drawings and specifications. All related works needed to have this work completed shall also form part of this section. Completion of the Works is required **within One Hundred Eighty (180) Calendar Days**. The description of an eligible bidder is contained in the **Bidding Documents, particularly, in Section II. Instructions to Bidder**.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, cooperative and partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from **Camarines Sur Polytechnic College** and inspect the Bidding Documents at the address given below from **9:00 A.M. to 4:00 P.M. on September 11 to November 8, 2018**.

A complete set of Bidding Documents may be acquired by interested Bidders from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **FIVE THOUSAND PESOS (₱5,000.00)** from **September 11 to November 8, 2018; 9:00 AM**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the College, provided that Bidders shall pay the non-refundable fee for the Bidding Documents not later than the submission of their bids.

The **CAMARINES SUR POLYTECHNIC COLLEGES** will hold a Pre-Bid Conference on **October 26, 2018 at 9:30 A.M.** at Board Room, 2nd Floor, Administration, Building, which shall be open to prospective bidders.
