INVITATION TO BID FOR PROVISION OF ROAD NETWORK ALONG FOUR STOREY ACADEMIC BUILDING (CEAS BLDG)-Reposting

The **CAMARINES SUR POLYTECHNIC COLLEGES**, through the **General Appropriation Funds (GAA)** intends to apply the sum of **One Million Five Hundred Thousand Pesos & 20/100 (₱1,500,065.98)** being the Approved Budget for the Contracts (ABC) to payments under the contract for the **Provision of Road Network Along Four Storey Academic Building (CEAS Building)**. Bids received in excess of the ABC shall be automatically rejected a bid opening.

The **CAMARINES SUR POLYTECHNIC COLLEGES** now invites bids for **the project Provision of Road Network Along Four Storey Academic Building (CEAS Building)** shall include all management, labor, engineering materials, tools, equipment and services required to manufacture, assemble, deliver and install all items necessary for the proper execution and completion of the said items of works. This is also includes all equipment and the performance of all operations necessary to perform Siteworks, Concrete Works and Ancillary Works of the project as indicated on drawings and specifications. All related works needed to have this work completed shall also form part of this section. All related works needed to have this work completed shall also form part of this section. Completion of the Works is required **within Sixty (60) Calendar Days**.

Bidding will be conducted through open competitive bidding procedures using non-discretionary pass/fail criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, cooperative and partnerships, or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

Interested bidders may obtain further information from **Camarines Sur Polytechnic College** and inspect the Bidding Documents at the address given below from **9:00 A.M. to 4:00 P.M. on March 16 to May 8, 2018**.

A complete set of Bidding Documents may be acquired by interested Bidders from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (5,000.00) Only** from **March 16 to May 8, 2018, 9:00 AM**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the College, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

The **CAMARINES SUR POLYTECHNIC COLLEGES** will hold a Pre-Bid Conference on **April 26, 2018 at 9:30 A.M.** at Board Room, 2nd Floor, Administration, Building, which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat at the address below on or before **May 8, 2018 at 9:00 o'clock A.M.** at Board Room, 2nd Floor, Administration Building, CSPC, Nabua, Camarines Sur. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated below (ITB Clause 18):
