



INVITATION TO BID FOR Procurement of Materials, Equipment & Installation for the Enhancement of Network and Internet Facilities of the College

The CAMARINES SUR POLYTECHNIC COLLEGES, through the **GAA** intends to apply the sum of **FIVE MILLION PESOS (₱5,000,000.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for the **Procurement of Materials, Equipment & Installation for the Enhancement of Network and Internet Facilities of the College**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

The CAMARINES SUR POLYTECHNIC COLLEGES now invites bids for the abovementioned procurement. Delivery of the Goods is required **within Thirty (30) calendar days**. Bidders should have completed, within **Two (2) Years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

Bidding is open to all interested bidders, whether local or foreign, subject to the conditions for eligibility provided in the IRR of RA 9184.

Interested bidders may obtain further information from the COLLEGE and inspect the Bidding Documents at the address given below from 9:00 AM to 12:00 Noon and 1:00 PM to 4:00 PM starting **May 29, 2018 to June 27, 2018** except Saturdays and Sundays.

A complete set of Bidding Documents may be acquired by interested Bidders on **May 29, 2018 to June 27, 2018 (9:00 am)** from the address below and upon payment of a nonrefundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Five Thousand Pesos (P 5,000.00) Only**.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the College, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.



The CAMARINES SUR POLYTECHNIC COLLEGES will hold a Pre-Bid Conference on **June 15, 2018** at 9:30 A.M. at the **Board Room**, 2nd Floor, Administration Building, CSPC, Nabua, Camarines Sur, which shall be open to prospective bidders.

Bids must be duly received by the BAC Secretariat at the address below on or before **June 27, 2018 at 9:00 A.M.** All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 18.

Bid opening shall be on **June 6, 2018 at 9:30 o'clock a.m.** at the **Board Room**, 2nd Floor, Administration Building, CSPC, Nabua, Camarines Sur. Bids will be opened in the presence of the bidders' representative who choose to attend at the address below. Late bids shall not be accepted.

The CAMARINES SUR POLYTECHNIC COLLEGES reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
